**Chairman Comments:** 6:31 Chairman Frederick commented that the Stein Farms Resolution is still pending due to building inspections. The Deputies contract has been approved and will be heard in the October Budget proposal.

2019 Wisconsin Department of Justice/JAG Crisis Intervention Team (CIT) Training Grant

6:32 Chief Deputy Levin advised the grant will be used to provide training to Deputies and Correctional staff who have already completed the 40-hour intervention training. The grant is for \$10,000 that is 100% funded and does not require a match; therefore, no additional tax levy dollars are being requested. Supv. Wamboldt asked how many staff members would be going and if this included other agencies. The number attending is unknown at this time and other agencies will be attending the training.

**Country Thunder Re-Cap:**

6:33 Chief Deputy Levin stated Country Thunder was relatively uneventful this year; weather was believed to have an impact. Total number of arrests and citations issued declined from past years. One hundred and seventy-three citations were issued; 155 being for underage drinking. There were 8 criminal arrests for Battery, Disorderly Conduct, Possession of Cocaine, and a Probation violation. Twin Lakes Police Chief reported that there were no major Country Thunder incidents for their department; 0 arrests, 7 underage drinking citations, 35 traffic stops, and 10 calls from citizens complaining about music from the festival. Genoa City reported they issued 41 citations during Country Thunder and that overall the traffic was managed well. Staffing for the campgrounds consisted of 4-6 deputies from 4 AM – 1 PM and 22-28 deputies from 1 PM – 4 AM. Festival site had 4-6 deputies from 2 PM- 5PM and 8-12 deputies from 5 PM – 2 AM. Traffic control posts consisted of 4-8 deputies from 3 PM- 1 AM. KPD was the only outside agency to assist KSD on Country Thunder grounds; Walworth County did assist with traffic posts. Country Thunder provided improvements including gravel added to entrances and exits, and campsite location changes. Planning and Zoning plans to meet with KSD and Country Thunder to make next year even better. Supv. Rodriguez commented on lack of security measures in relation to the entrance having no security, scanners or metal detectors. Levin agreed that security measures would be helpful but those are procedures the Country Thunder organization would have to institute.

***Any Other Business Allowed by Law:*** 6:50 Rodriguez inquired about the Mobile Command Unit being present at the Tall Ships event downtown and who would be paying for their presence. Levin advised that security levels were raised by all involved due to ships being from foreign ports.

***Meeting Adjourned:*** 6:52 on motion by Rodriguez; seconded by Yuhas.
